**Tuition Rates and Settlement**

Registration fees are due on the day of registration. Registration fees cover costs of processing and testing, and are non-refundable.

Registration Fee-----	\$200.00 per child for the year.
Full-Day Kindergarten (3 & 4 year) -----	\$3990.00 per child for the year.
K5 – Elementary Tuition (K5 – 5 <sup>th</sup> )-----	\$4,390.00 per child for the year.
Secondary Tuition (6 <sup>th</sup> - 12 <sup>th</sup> )-----	\$4,640.00 per child for the year.
Building Fund -----	\$500.00 per child for the first two children in the family.
Book Fee (K3 – 12 <sup>th</sup> ) -----	\$150.00 per child for the year.
Technology Fee (K3 – 12 <sup>th</sup> )-----	\$35.00 per child for the year.

Building Fund is payable in \$100.00 payments over a 5 year period.

Tuition is due on the 1st of each month and considered past due after the 16<sup>th</sup>. A 10% late fee is accessed on the 20<sup>th</sup>. Students are accepted for the whole school year and all tuition, building fund and fees are payable on this same basis. Any other arrangements must be presented to the Board of Directors for its approval.
